Minutes of Previous Meeting and Matters Arising	 Minutes were approved by Cathy B Morrison and seconded by Steve McCombe. <u>Donnie MacKay</u>: It was decided to present Donnie with a gift as a token of appreciation for his work with the Trust and Trading Company over the years. Calum will speak to Donnie to find out what would be suitable. <u>Mountain Festival</u>: This year's Mountain Festival has been a success with good attendance at events. Calum expressed thanks to Matt for his input leading up to and during the week of the festival. The subject of inclusion of Gaelic during the festival was raised and this will be looked into for next year. 		
3.	Staff Reports	 An email will be sent out to all Trust and Trading Co to remind them of the Forward Planning Day. Gordon has spoken to SNH regarding the proposed Stock Club. They are willing to support the venture but it would also need to be supported by SGRIP. Gordon will meet with SGRIPD to discuss further. Tenants in Scalpay School were quite happy with the proposed future rents if the School is acquired by the Trust. There is a problem with Scottish Water billing as the School House water usage is included in the bill. Ann-Marie has contacted CNES and SW regarding the issue and is awaiting developments. HIE are keen for the Trust to become involved in the Scalpay Development Trust and Butha Scalpaigh on an advisory capacity. HIE are conducting a full financial audit of the business and it was decided to await the outcome of the audit before agreeing to any involvement. It was also felt that the invitation to the Trust to become involved should come from the shop committee rather than from HIE. An answer from the Scalpay Community Council is needed on the outcome of plans for the

		 future of the Care Unit. Ann-Marie will write to ask. A decision is needed from them as soon as possible. The Croileagan building is now near completion and looks great. Rionnagan Og have secured funding from SportScotland for the soft play area and they are hoping to begin installing the equipment at the start of October. The other group currently using the building are satisfied with arrangements for their continued use. There was an issue with people using metal detectors on the Whaling Station site. Karen has made a sign with information regarding access to the site which should deter visitors. The grid offer for the 100kw Marig hydro scheme was accepted but since then SSE have suspended all new grid connections over 10kw. David is investigating the possibility of securing the grid connection as the offer was accepted and paid for before the announcement. Alistair raised concerns that the Carragreich turbines could prevent future developments on the Kyles ridge. Calum asked whether a grid connection offer had been received for the Carragreich turbines. Alistair will clarify this point with David tomorrow. Alistair and Diana met with Nick Cotton, BoS Business Advisor, who is satisfied with account management within the Trust. He also informed them that he could not see any problem with an increase in overdraft facility, if necessary, for future projects.
